- 1. Complete all sections fully. Assure that you provide your Live Fish Dealer License number from the PA Department of Agriculture in Section B. Incomplete applications will be returned without action.
- 2. Send a completed paper application form and any supporting documents together with the fee of \$85.00 to the Pennsylvania Fish and Boat Commission, Division of Environmental Services, 595 East Rolling Ridge Drive, Bellefonte, PA 16823.

- 4. Any party, including the applicant, who is aggrieved by a decision of the Executive Director to grant or deny a permit under Section 2906 of the Code, may appeal the decision to the full Pennsylvania Fish and Boat Commission. Appeals must conform to 1 Pa. Code § 35.20. The Executive Director may stay a permit upon filing of an appeal. Appeals shall be disposed of in accordance with the General Rules of Administrative Practice and Procedure, as amended or supplemented by Commission rules.
