# PA RESIDENT LANDOWNER FISHING LICENSE APPLICATION

**LICENSE FEES ARE NOT REFUNDABLE — LICENSES ARE NOT TRANSFERABLE**

Eligibility Requirements (You must meet each requirement to qualify.)

**Resident owner or lessee of a farm with 80 or more acres may obtain a resident fishing license at one-half the regular fee if:**

1. The owner/lessee is a bona fide resident of the Commonwealth of Pennsylvania. *Proof of residency is required.*
2. The farm includes 200 linear feet of a stream, creek, river or a one-half acre pond. All water areas of the farm must be open to free public fishing.
3. The Commission is authorized to post "fishing permitted" signs.
4. A conservation plan has been developed for the farm that is not in conflict with the Clean Streams Law (P.L. 1987, No 394) and meets the requirements of 25 Pa. Code - Chapter 102 (relating to erosion and sediment control). *A copy must be submitted with this application.*
