American Eel Dealer Reporting Instructions

- 1) PA Department of Agriculture Registered live fish dealers should provide reports for all sales or purchases of American eels (dead or live) after December 31, 2006.
- 2) Reports are due on a quarterly basis by the 10th day of the following quarter (April 10, July 10, October 10, and January 10). Submit via "Contact us" email or mail options listed below.
- 3) Copies of the form are acceptable, or new forms may be requested via "Contact us" options listed below.
- 4) On the enclosed form please report:
 - a) The dealer's name, PA Department of Agriculture registration number, address, telephone number, and e-mail address
 - b) The name and title of the person completing the form on behalf of the dealer.
 - c) Date of each <u>wholesale</u> purchase or sale; <u>aggregate retail sales by life</u> <u>stage can be reported quarterly.</u>
 - d) Name, state or province, and country of wholesale buyer (individual or company to whom you *sold* eels) or seller (individual or company from whom you *bought* eels); this information is not required for aggregate retail sales.
 - e) The life stage (glass eel, elver, yellow eel, or silver eel)
 - f) The intended use (Bait, Food, or Other); if other, please specify
 - g) The total pounds, by life stage, for each purchase or sale. For small numbers of eels, reporting of numbers is acceptable, but this should be noted on the form. Aggregate retail sales should be reported as total pounds.
- 5) All forms must be signed. By signing the report, you are certifying under penalty of law that the information provided is true and correct to the best of your knowledge, information and belief.
