



## Application for Transfer of Registration Fee to a Newly Acquired Boat

**Use this form to transfer a boat registration fee from a boat you own to a newly acquired boat. You may transfer the remaining registration period and value from the original boat to a new boat. Boat Registration Numbers are Not Transferable.**

### Instructions:

- Complete Sections A, B, C and D and submit the old Certificate of Registration (registration card) with this application. Your transfer of registration cannot be processed without the old Registration Card.
- Remove the validation stickers on your old boat.
- Fee for a transfer of registration is **\$5.00**, plus the difference (if any) between the registration fee for the original boat and the new boat. *(See the back of this form to calculate your registration fees).*
- Obtain, form REV-336, *Application for Boat Registration and/or Boat Title*. Complete form REV-336 with information about your newly acquired boat. Attach form REV-336 to this application.
- Do not send cash. Make your check or money order payable to: **Pa Fish and Boat Commission**.

<b>Boats 16 feet but less than 20 feet</b>	<b>\$39.00</b>
<b>Boats 20 feet and larger</b>	<b>\$52.00</b>
<b>Unpowered Boats</b>	<b>\$22.00</b>
