- ☞ If this application is processed, and the requested title, registration, or both are not received due to loss in the mail, you may apply for free duplicate title on form PFBC-T1, and a free replacement of registration within 90 days of the date of original issuance.
- ☞ Fee for issuance of a corrected title: \$15.00. Do not send cash. Make check or money order payable to the Pennsylvania Fish and Boat Commission (PFBC).
- ☞ Owner and co-owner, if applicable, must sign.
- ☞ If the boat is in the name of a company/corporation, the signature and title of an authorized representative is required.

Instructions (Title Must Be Attached)

If Block 1, Correction of Hull Identification Number (HIN) is checked:

- Certificate of Title and \$15.00 title fee MUST be attached.
- This form can only be used to correct typographical error of one digit or transposition of two digits.
- Complete Sections A, B, C and F.

If Block 2, Application for Pennsylvania Fish and Boat Commission Issue Hull Identification Number (HIN) is checked:

- Certificate of Title and \$15.00 title fee MUST be attached.
- Pennsylvania Fish and Boat Commission issue Hull Identification Number will be used on boat. A new title and registration card will be issued indicating PAZ HIN identification number.
- Section D must be completed by a Pennsylvania Fish and Boat Commission Waterways Conservation Officer (WCO). The WCO verifying the original Hull Identification Number must provide his or her name, telephone number and sign his/her name.
- Complete Sections A, D and F.

If Block 3, Change or Correction of Name or Address is checked:

- Certificate of Title and \$15.00 title fee MUST be attached. *No fee required for Change of Address if you do not want a replacement title.*
- If name is changed by permission of court, attach a certified copy of the court order.
- Complete Sections A, B and F.

If Block 4, Change of Boat Information is checked:

- Certificate of Title and \$15.00 title fee MUST be attached for all changes or corrections except Outboard Motor information not previously displayed on the title. A new title will not be issued for these exceptions.
- Complete Sections A, E and F.
